





Specifications

The Double Check Detector Backflow Preventer shall be certified to NSF/ANSI 61, ASSE® Listed 1048 and supplied with full port OS & Y gate valves. The main body and access cover shall be epoxy coated ductile iron (ASTM A 536 Grade 4), the seat ring and check valve shall be NORYL[™], the stem shall be stainless steel (ASTM A 276) and the seat disc elastomers shall be EPDM. The checks shall be accessible for maintenance without removing the device from the line. The Double Check Detector Backflow Preventer shall be a ZURN WILKINS Model 450DA.
